

DCBA ID REGISTRATION DOCUMENTS

(I) Document List for Junior Players

- 1. **Duly filled DCBA Form** Complete the form online and attach all required documents.
- 2. **Bonafide Certificate** Must be verified by the current school.
- 3. **Birth Certificate** The birth should be registered in the same year. If not registered in the same year, a **Medical Certificate in BAI format** verified by the **CMO from Any Government Hospital** is required.
- 4. **Self-attested photocopy of Aadhar Card** Front and backside.
- 5. **Notarized Affidavit** on ₹10/- stamp paper Duly signed by the deponent as per the attached format.
- 6. **Processing Fee** ₹1000/- for generating the DCBA ID.
- 7. Two passport size color photographs
- 8. Player Declaration Letter
