1. **Duly filled DCBA Form** – Complete the form online and attach all required documents.
2. **Bonafide Certificate** – Must be verified by the current school.
3. **Birth Certificate** – The birth should be registered in the same year. If not registered in the same year, a **Medical Certificate in BAI format** verified by the **CMO from Any Government Hospital** is required.
4. **Self-attested photocopy of Aadhar Card** – Front and backside.
5. **Notarized Affidavit** on ₹10/- stamp paper – Duly signed by the deponent as per the attached format.
6. **Processing Fee** – ₹1000/- for generating the DCBA ID.
7. **Two passport size color photographs**
8. **Player Declaration Letter**
