1. A player is eligible to participate in maximum 4 events.
2. Applying for DCBA ID is mandatory to participate in Delhi State Tournaments.

The entry fee for qualifying shall be as follows.

**Entry Fees** :: Singles events of all categories -- Rs. 1000/- per player per event

Doubles events of all categories-- Rs. 2000/- per pair per event

**Mode of Competition** :: All matches shall be played on knockout basis and best of three games of 21 points in rally point system.

**Regulations** :: The BAI Competition Regulations and General Competition Regulations shall be applicable. In the event of any dispute, the decision of the Tournament Referee will be final.

<b>Clothing Regulation</b>	::	Players must comply with General Competition Regulations.
<b>M&amp;C</b>	::	M&C List will be published on 22 <sup>nd</sup> May & 23 <sup>rd</sup> May 2024. It shall be the responsibility of the players to ensure that all the entries forwarded appear in the List. If there is any omission, the player/s concerned immediately should contact DCBA. After the Last date, no complaints shall be entertained for omission of any entry. DCBA will not be responsible for any omissions of names thereafter.
	::	Entry Fees will not be refunded
<b>Shuttles</b>	::	Transform VT 50
<b>Tournament Seeding</b>	::	As per the current ranking on DCBA Website (i.e. 1 <sup>st</sup> May 2024)
<b>Protest</b>	::	A non-refundable fee of Rs 1000/- will be charged against age protest. Each complaint or protest will be forwarded to DCBA and course of action will be decided by the appointed Tournament committee. The decision of the committee will be final.
<b>Line Judges</b>	::	Line judges may not be appointed for the matches till the quarterfinals. There will be line judges for semifinals & finals.
<b>Badminton Integrity</b>	::	To protect the integrity, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the organising committee any approaches by anyone to gather inside information or to change the outcome of a match(es). - All players must carry your Aadhar Card, Current Year School ID Card or Office ID-Card, Date of Birth Certificate issued by the MCD and registered in the same year.
- If the Date of Birth and its Registration is not of the same year, then player must submit Medical Certificate as per BAI format and Average AGE will be calculated as per the Medical Certificate.
- In Paired events both players must mention partner name. Entry shall not be accepted without the partner's name.
- Each player will pay his own entry fees (e.g., For Doubles event entry fees is 1000 Rs. for each player).
- In paired events partners should play in same sports attire.
- Player should be prepared to play his/her next match with a rest period of maximum 30 minutes.
- Players are the solely responsible for their belongings at the venue. Organizer will not be responsible for any loss.
- All the players participating in this tournament shall maintain strict discipline on & off the court.
- The Organizers are not responsible for any mishap, inside/outside the venue during the tournament.
- All the players are supposed to report at least 20 minutes before their actual match timing.
- The Matches will be played according to the Schedule and No match will be Rescheduled. If the player is not found at the scheduled time of his/her match, walkover shall be given.
- The Decision of the Tournament Committee will be final & binding on all Points of Facts.
- The Chief Referee will be the Sole in charge of all Technical Issues on Point of Law.
